

Privacy Policy

This Privacy Policy ("Policy") applies to www.mymokafe.franchise.com, and MOKAFÉ Corp LLC ("Company") and governs data collection and usage. Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. - Enable solely internal uses that are reasonably aligned with your expectations based on your
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with
